Introduction

Index Objective

The VettaFi Fund-Tracking Index Family is composed of indexes that track the performance of an ETF.

Dates

Rebalance/Reconstitution Dates: Indexes rebalanced/reconstituted quarterly at the close of trading on the third Friday of each calendar quarter. If the third Friday is a market holiday, the rebalance will take effect at the close of trading on the preceding trading day.

Reference/Weight Dates: Five trading days prior to Rebalance/Reconstitution Date.

Constituent Weightings & Constraints

Weights are based on fund market values and remain fixed from the Weight Date through the Rebalance/Reconstitution Date.

Index Maintenance

Rebalancing and Reconstitution

The Indexes are rebalanced on the “Rebalance Date” and additionally reconstituted on the “Reconstitution Date”. Pricing used in share weights used for reconstitutions are as of the “Weight Date”. Share weights for the rebalanced Indexes are computed as of the “Weight Date”. Changes to the Indexes related to the rebalances are as of the “Rebalance Date”. Additions are only made on reconstitution dates.

Dividends

Dividends are recognized the day after the stated ex-date.
