Index Objective

The Buena Vista DEX VettaFi Neos CDI PLUS Index is designed to provide returns from the Brazilian government's LFT bonds and FX hedged returns from FIXX11 (Buena Vista Neos Enhanced Income ETF), AURO11 (Buena Vista Neos Gold High Income ETF), QQQQ11 (Buena Vista Nasdaq-100 High Beta ETF) and TOPY11 (Buena Vista DEX Vettafi Neos Multiestrategia High Income ETF) in BRL.

Highlights

The index combines returns from ~~five~~^{two} components with fixed weights: ~~72~~⁸⁰% from the local Brazilian government's LFT index. The other 28% is allocated:- 15% from the FIXX11 ETF index, and 10% from the AURO11 ETF index, 2% from the QQQQ11 ETF Index and 1% from TOPY11 ETF index which are hedged using one-month forwards to offset the FX exposure of the underlying ETF indices. The index is also calculated with a set decrement of 50bps.

Dates

The index is a composite of ~~three~~^{five} underlying indices, and their dates are governed by their underlying components. The inception of this index is ~~June~~^{August} ~~2029~~²⁰²⁶.

TMX VettaFi FX BRL/USD Forward Hedge Index – FX component to hedge the USD exposure of TMX VettaFi FIXX11 ETF Index, ~~and~~ TMX VettaFi AURO11 ETF Index, [TMX VettaFi QQQQ11 ETF Index](#) and [TMX VettaFi TOPY11 ETF Index](#) which are based in BRL without FX hedges whose underlying instruments are in USD. This index uses one-month BRL/USD forward contracts held until the end of the next month, valued using FX spot rates and interpolated forward contract.
