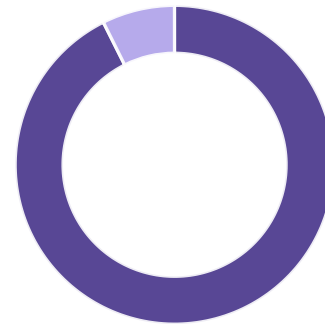

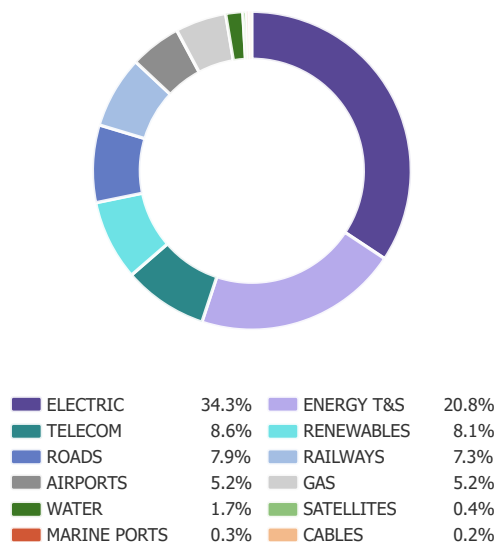

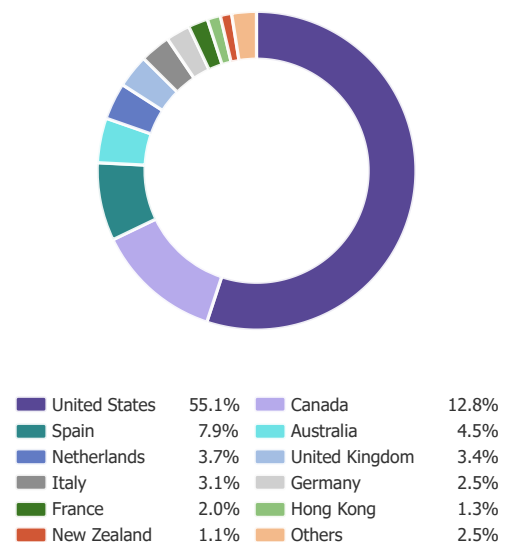
Market Capitalization
