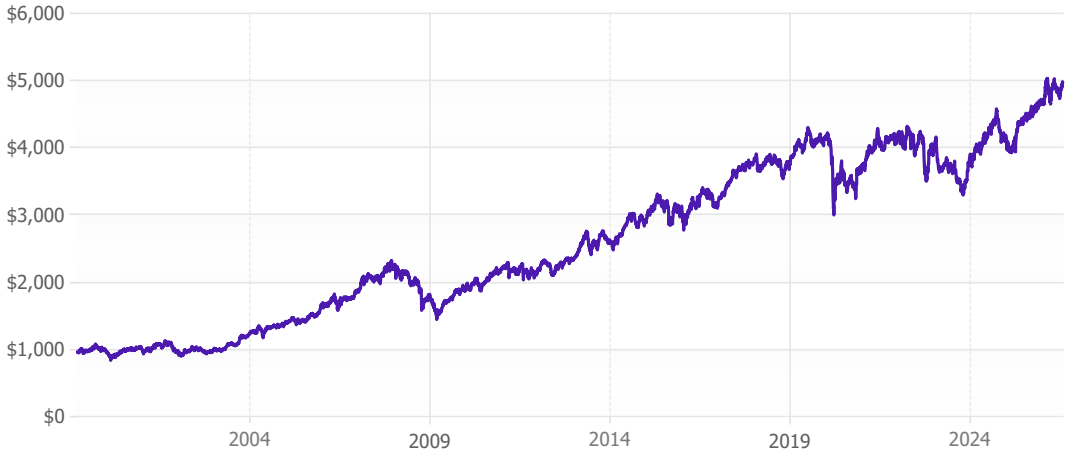

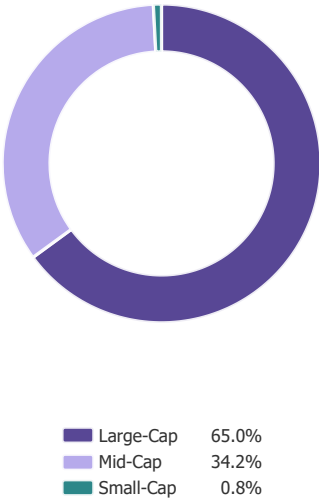

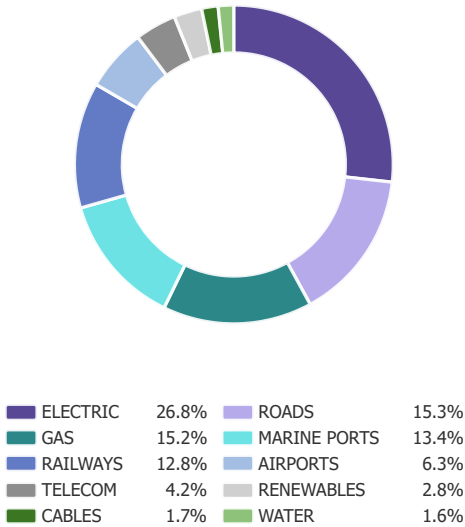

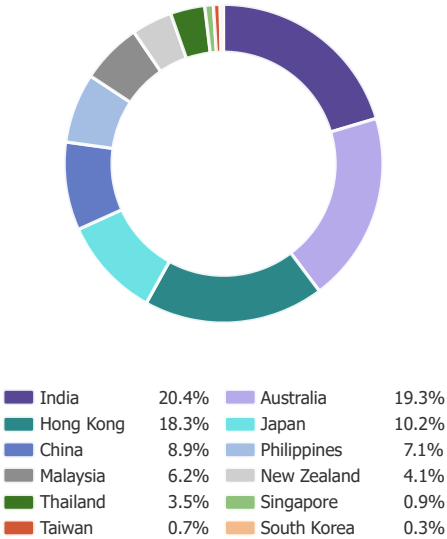
Market Capitalization
